The event will be conducted under the tournament rules of the Scottish Badminton Union, including the prohibition of doping, for which tests may be carried out.

Competitors must be members of clubs affiliated to the Scottish Badminton Union.

The committee reserves the right to refuse any entry without giving a reason and to alter the order of play if necessary.

No entry will be accepted from a player who has taken part in any unauthorised tournament, league, or match.

Competitors must report to the referee on arrival.

Players not available to play when called may be scratched.

IT IS THE INTENSION TO PLAY THE FINALS ON THE SUNDAY, THEREFORE ALL COMPETITORS SHOULD BE AVAILABLE TO PLAY ON THAT DAY.

Feather shuttles will be used.

Entry fees and SBU levies and programme fees must accompany the entry form.

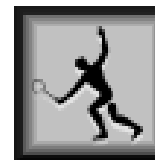
